purchase of a blanket warmer for the Grand Rapids Veterans Home and eight Assist Wheel Chairs for the Veterans Hospital in Saginaw. FRIAR'S FORUM

Perhaps you've noticed how the liturgy often refers to the life of heaven. We pray that we will not only be prepared to go to heaven, but that we will also start living the kingdom of heaven here on earth.

You might wonder how the life of heaven is possible amid our daily routines and problems. But before we start singing Peggy Lee's old tune "Is That All There Is?" let's try to understand what our Christian tradition is saying. Then let's go one step further and ask how we as Knights of Columbus might understand this truth of our faith.

PERFECT LOVE

The Church teaches us that heaven is eternal life with God. It is participating in the life and love of the Holy Trinity with all the saints in a state of supreme happiness. Heaven is sharing with our whole being in God's love — the only love that satisfies the longing of our heart.

Obviously, we aren't there yet. Many people are alienated from God and even deny that he exists. The world is torn by wars and all kinds of human suffering. We ourselves may at times give in to estrangement, division and self-centeredness. To the extent that we do so, we are not living the life of heaven.

We might wonder, then, why an all-loving and all-powerful God doesn't just give us a pass. After all, life can be pretty irksome. Instead, Jesus taught us, "Be perfect, just as your heavenly Father is perfect" (Mt 5:48). In other words, "Be merciful, just as your Father is merciful" (Lk 6:36).

Heaven is a place of perfect love. When we love others, especially the poor and needy, then we begin to experience something of the wonder and awe of heaven. When we keep the Ten Commandments in the spirit of the Beatitudes, we start living the life of heaven on earth. As we say in the Lord's Prayer, "Thy kingdom come, thy will be done, on earth as it is in heaven."

So what does this mean for the Knights of Columbus? Let me suggest that the four principles of our beloved Order are four keys to living the life of heaven. I am convinced that our venerable founder, Father Michael J. McGivney, gave us these principles because as a follower of Christ and as a devoted priest, he was already living the life of heaven amid his strenuous pastoral labors. Following his lead, let's see how these principles help us to experience heaven right here and now.

HEAVENLY PRINCIPLES

We begin, as always, with charity. St. John the Evangelist sums up the very heart of Scripture when he says, "God is love" (1 Jn 4:8, 16). The three Persons of the Holy Trinity love each other with a love that is pure, passionate and beautiful.

What's more, we are created for love. St. John Paul II often said that our lives don't make sense without love.

When we open our hearts to God's grace, which is revealed in Christ's gift of self on the Cross and so readily available to us in the sacraments, and allow ourselves to be drawn into God's life and love, we experience great joy. It isn't just the fleeting happiness we feel when things are going well; it is the joy of the Holy Spirit that endures.

God's love poured into our hearts is the source of charity. "We love because he first loved us" (1 Jn 4:19). The more we welcome God's love, the more we will be moved to reach out to those around us in love and service. Love is more than a short-lived emotion; love seeks to share with others the gift of divine love that God has shared with us.

No wonder Father McGivney made charity the first principle of Order. When brother Knights provide coats for inner-city children, support Special Olympics or simply help fellow parishioners in need, they are in small ways manifesting heaven on earth.

Charity, of course, gives rise to unity: a oneness in professing and living our faith, and in our dedication to the Order's principles. It means that when we, the family of the Knights of Columbus, engage in works of charity, we find ourselves united in friendship and in mission. Indeed, when we build unity in our Order and in our Church, we start sharing in the joy of heaven. In fact, heaven is where the saints are completely united in God's life and love. There are no divisions or disputes.

Unity, in turn, leads to fraternity. In heaven, all are united as brothers and sisters because, through Christ and in the Holy Spirit, they rejoice together in the presence of God the Father. There, the Lord's words are perfectly fulfilled: "For you have only one Father who is God and you are all brothers and sisters" (cf. Mt 23:8-9). In our care and concern for our fellow Knights and their families — our readiness to reach out to them in times of trouble, illness, loneliness or financial hardship, and our desire to support one another in living and bearing witness to the faith — we are bearing witness to heaven here on earth.

Finally, I'd like to offer a word about patriotism. Many of our brother Knights and their family members have sacrificed for love of their homeland. Yet, even as we love our native land on earth, our true native land in heaven calls to us. Every desire, every feeling of discontent, is a tug at the heart from heaven, which is not an idyllic country but rather the life of God himself. So when we hear the liturgy talk about living the life of heaven even now, let's never dismiss such talk as "pie in the sky." No, let's get down to the business of living the heavenly life today.

CIVICS 101 "The White House"

The city of Washington was created to replace Philadelphia as the nation's capital because of its geographical position in the center of the existing new republic. The states of Maryland and Virginia ceded land around the Potomac River to form the District of Columbia, and work began on Washington in 1791. French architect Charles L'Enfant designed the area's radical layout, full of dozens of circles, crisscross avenues, and plentiful parks.

Thomas Jefferson was among the many people who submitted a plan for the White House. His design, however, was not chosen. Instead, James Hoban, an Irish immigrant architect living in Charleston, South Carolina, won the competition and a \$500 prize, with a design modeled after Leinster House (in Dublin, Ireland) and by a building sketch in James Gibbs' Book of Architecture. In 1792, work began on the neoclassical White House building at 1600 Pennsylvania.

Although George Washington helped to choose the site for the residence while he was president, he never lived at the famous house. The cornerstone of the White House was laid on October 13, 1792. Eight years later, John Adams, the second president, and his wife Abigail, moved into the mansion. A competition had been held to design the presidential residence. On November 1, President John Adams was welcomed into the executive mansion. His wife, Abigail, wrote about their new home:

"I pray heaven to bestow the best of blessings on this house, and on all that shall hereafter inhabit it. May none but wise men ever rule under this roof!"

In 1814, during the War of 1812, the White House was set on fire along with the U.S. Capitol by British soldiers in retaliation for the burning of government buildings in Canada by U.S. troops. The burned-out building was rebuilt and enlarged under the direction of James Hoban, who added east and west terraces to the main building, along with a semicircular south portico and a colonnaded north portico. The smoke-stained stone walls were painted white. Work was completed on the in the 1820s.

President Theodore Roosevelt officially adopted the term "White House" in 1901. While President and Mrs. Roosevelt and their six children lived at the White House, the second-floor rooms were converted into living quarters. The West Wing was also built during this period to house the presidential staff.

Major restoration occurred during the administration of President Harry Truman, and Truman lived across the street for several years in Blair House. Since 1995, Pennsylvania Avenue between the White House and Lafayette Square has been closed to vehicular traffic for security reason. Today, more than a million tourists visit in the nation's capital.

Here are 5 facts you can use to impress your family and friends about the White House.

- Another city built its own version of the White
 House. Philadelphia wasn't happy that the city of
 Washington was getting the president's executive
 mansion. During the 1790s, the city built its own
 presidential palace as a way to tempt George
 Washington and others from leaving Philadelphia.
 Washington refused to use the "palace" and stayed
 elsewhere in Philadelphia. That location is two blocks
 south of the National Constitution Center.
- 2. Very little of the original White House remains. When the British burned the original White House in 1814, only some exterior stone walls survived the fire. The famous Gilbert Stuart painting of George Washington was saved by a fleeing Dolly Madison.
- 3. A second fire on Christmas Eve in 1929 gutted parts of the West Wing and Oval Office during the Herbert Hoover administration. Hoover left a Christmas party to personally direct the firefighting efforts, helped by Ulysses S. Grant III, a city official. The blaze was started by a blocked fireplace flue.
- 4. It was Teddy Roosevelt who created the West Wing. The West Wing was expanded under William H. Taft and Franklin D Roosevelt, but it was Teddy who got the facility built. Thomas Jefferson had started the ball rolling with the idea 100 years earlier, Teddy had some conservatories leveled and the "temporary" office building established, to be connected to the main White House using a colonnaded gallery. President Taft added the Oval Office to the West Wing.
- 5. The White House was nearly condemned in 1948. President Harry S. Truman was forced out of the White House as his living quarters to the Blair House after officials decided the aging White House was close to collapsing. The repair budget under the FDR administration was ignored, even as more White House staffers were added to payrolls. When Truman tried to upgrade the White House, engineers discovered it was structurally unsound and close to falling down. The project was completed in 1952.



Right to Life Issues

Putting Pro-Life values first when voting

"Why do you have to get involved in politics?" That's a question I get from people who disagree with our endorsement of candidates. It's a fair question. Many citizens are unhappy with their elected officials, feeling they are unresponsive or once elected change their positions. We need to be actively engaged in vetting and supporting candidates because that is one way to impact the abortion culture. Prolife bills need to be passed; proabortion bills need to be defeated. "You have rocked the country and split it open; repair the cracks in it, for it is tottering."

We are called to repair the wrongs created through the U.S. Supreme Court abortion decisions which have caused so much harm and suffering. We do that through education and outreach. We do that through political action by endorsing and supporting prolife candidates. We do that by then lobbying those prolife legislators to enact protective laws. Every life has meaning; so does every vote. Let us put our prolife values first when voting. Make your vote count in repairing the cracks!

COMMANDER'S CORNER

Communication with Celebrants

Perhaps you have a Corporate Communion scheduled, complete with Color Corp, in just a few short weeks. As the Color Corp Commander, you'll want to make sure that you have taken care of the following:

- Communicate with the celebrant of the mass to see if swords may be drawn in church.
- Secure permission to escort the gift bearers.
- Ask if there is a second collection or any special event (such as the blessing of a couple celebrating their wedding anniversary), and if so, when during mass will this occur.

Some Commanders choose to email these questions to the priest a couple of weeks in advance. This is an effective planning tool, especially because many of our priests are traveling from one parish to another, and their time is often at a premium.

Reserving pews for Color Corp Estimate the number of CC that will be participating and reserve space for them in the back pews, on both sides of the center aisle, if possible. Be sure that you have secured permission from the head usher.

Lining up the Color Corp When the Marshal is not present and the Commander is in charge, the host Commander takes point and lines up the Color Corp in two columns as follows:

Host Commander
Masters
Former Masters
Commanders
Faithful Navigators
Past Faithful Navigators
Red Capes (shortest to tallest)

Processing into church

Once the Color Corp is lined up and are ready to process into the church by way of the center aisle, the Marshal or CCC gives the signal to draw sword, carry sword, and then march. (Make sure all of your CC members know that we always start with our left foot.) The M or CCC, followed by the CC, marches to the front of the church. When the M or CCC reaches the front pew, he stops and waits for a few seconds until all of the CC have reached their places next to their respective pews. Now the M or CCC (only) goes to present sword, venerating the altar. Next, the M or CCC goes to carry sword and does an about face. This is the Color Corp's cue to go to center face.

As the altar servers begin to process down the aisle, the M or CCC gives the signal to go to present sword. All swords should be held straight up and down, at such a height that CC members are looking just over the guard. Swords should slightly touch the front of the chapeau. Anyone looking down the aisle at the CC should see straight vertical lines of swords.

As the celebrant passes by the two CC at the end of the line, these two simultaneously go to carry sword, take a step toward each other, and then they turn toward the altar. This same process is repeated by each pair of CC as the celebrant passes them. When the celebrant has passed by the M or CCC, all CC should be two abreast, facing the altar. As the celebrant bows and kisses the altar, all CC bow at the same time. Both columns will go to their pews in the back of the church, by way of their respective side aisles.


Practices

Commanders should schedule practices throughout the year. One thought is to hold practice either before or after monthly assembly meetings.

Appearance

It is important that each Color Corp member looks sharp, therefore:

- Capes that are discolored or stained should be replaced
- Capes that have been damaged should be repaired or replaced
- Capes should be free of wrinkles
- Chapeau plumes that are discolored or worn need to be replaced
- Baldrics and gloves that are stained or discolored should be replaced
- Commanders are responsible for providing a sign up sheet for any and all Color Corp events.
